

CHARTER OF CITIZENSHIP

Preamble

Citizenship of the Statodellarte is not a nominal belonging but a practice. By accepting this Charter, the citizen recognises themselves in the principles of the Constitution of the Statodellarte and assumes their daily exercise as a living form of their own membership of the Statodellarte.

I. Adherence to the Fundamentals

The citizen adheres to the Fundamentals of the Statodellarte enshrined in Title I of the Constitution. They recognise in the trinamic Formula of Creation the guiding principle of the encounter between differences and in Demopraxia the approach for the sharing of knowledge and the taking of shared decisions. They operate in the awareness that every war is genocidal and every life it extinguishes is a universal crime.

II. The Communities of Practice

The citizen recognises that their own belonging to the Statodellarte is exercised in the communities of practice in which they operate daily - associations, foundations, enterprises, public and private bodies, committees and working groups - and commits to connecting those communities to the principles and activities of the Statodellarte, pursuant to Articles 9 and 71 of the Constitution. In the communities of practice with which they are in relation, they contribute to bringing out the sense of shared responsibility towards peace and sustainability.

III. Preventive Peace

The citizen takes Preventive Peace as the horizon of their action. Peace is not for them the mere absence of war, but a conscious choice founded on relationship, mutual recognition and sustainability in the relations between artifice and nature. They reject every predatory or domineering logic and work, within their own spheres, to build the conditions of peaceful coexistence.

IV. Trinamic Formula of Creation and Care of Differences

The citizen operates according to the trinamic Formula of Creation, recognising the legitimacy of the other to exist in their own difference. They welcome differences as a foundation and not as a threat, placing listening before judgement and the search for consensus before the logic of prevalence. They promote the practice of Demopraxia in the contexts in which they act.

V. Dissemination and Reporting of Experience

The citizen commits to bringing into their own communities of practice the experience of participation in the Statodellarte in the Opere Demopratiche, the Ambasciate, the Circoli di Partecipazione or in any other form, fostering the dissemination of the principles and messages of the Statodellarte and soliciting new memberships, pursuant to Article 72 of the Constitution.

VI. Contribution to the Functioning

The citizen contributes annually to the functioning of the Statodellarte, in the amount and manner established by the Camera, pursuant to Article 80 of the Constitution. The contribution is not a condition of adherence to the values but a concrete expression of responsibility towards the community. The citizen exercises the right to vote in the cases in which it is provided for, pursuant to Article 74 of the Constitution.

VII. Respect for Dignity and Countering of Obstacles

The citizen recognises that every human being is endowed with reason and conscience and is called to use their own creativity in a spirit of fraternity and mutual respect. They work to remove the obstacles that impede the equal enjoyment of rights and the exercise of the responsibilities arising from membership of the Statodellarte, pursuant to Article 12 of the Constitution. They counter every form of discrimination.

VIII. Compliance with the Rules

The citizen operates in compliance with the rules of the legal order of the country in which they carry out their activities and with those of international law, pursuant to Article 6 of the Constitution, as well as with the Constitution of the Statodellarte and the regulations issued by the Camera. They do not use the name, the symbol or the title of the Statodellarte for purposes of personal or partisan profit or otherwise in conflict with the Fundamentals.

IX. Renunciation and Forfeiture

They may at any time renounce citizenship by communication to the Presidency of the Camera; the contribution for the current year remains due. The violation of the principles of this Charter may be referred to the Collegio dei Garanti for the assessments within its competence, within the limits provided for by the Constitution.

X. Acceptance

The acceptance of this Charter is a condition for the recognition of citizenship of the Statodellarte, pursuant to Article 72 of the Constitution. By signing it, the citizen declares that they know and accept the principles and rules of the Constitution, that they recognise themselves in the principles expressed in this Charter and that they commit to practising them in the communities of practice with which they are in relation.

Validity

This Charter, elaborated by Cittadellarte and delivered to the Statodellarte pursuant to the transitional provisions of the Constitution, enters into force with the inaugural session of the Camera. It may subsequently be amended by the Camera by the procedure referred to in Article 56 of the Constitution, on the proposal of the Presidency. The amendments may in no case modify or alter the provisions of the Constitution.
