

CHARTER OF THE AMBASSADORS

Preamble

The Ambassador of the Statodellarte is called to produce and inspire a transformation of society in a responsible direction through creative ideas and projects, in close relation to the socio-cultural and economic characteristics of the territory in which they operate. By accepting the appointment conferred by the Presidency of the Camera, the Ambassador recognises themselves in the principles expressed herein and assumes their daily exercise as a living form of their mandate.

I. Adherence to the Fundamentals

The Ambassador adheres to the Fundamentals of the Statodellarte enshrined in Title I of the Constitution. They recognise in the trinamic Formula of Creation the guiding principle of the encounter between differences and in Demopraxia the approach for the sharing of knowledge and the taking of shared decisions. They operate in the awareness that every war is genocidal and every life it extinguishes is a universal crime.

II. Mission

The Ambassador works to make known the principles, aims and messages of the Statodellarte in their own territory and beyond, promoting Preventive Peace and sustainability in the broadest sense. They contribute to identifying and connecting the communities of practice, fostering the active participation of people and organisations in the life of the Statodellarte, in particular by facilitating the activation of Opere Demopratiche. They commit to promoting the formation and activity of Circoli di Partecipazione in their own territory and membership of the Statodellarte, in the spirit of Article 38 of the Constitution.

III. Trinamic Formula of Creation and Care of Differences

The Ambassador operates according to the trinamic Formula of Creation, recognising the legitimacy of the other to exist in their own difference. They welcome differences as a foundation and not as a threat, placing listening before judgement and the search for consensus before the logic of prevalence.

IV. Integrity and Representation

The Ambassador acts with integrity, transparency and coherence with respect to the values of the Statodellarte. They do not use the title, the symbol of the trinamic Formula of Creation or the name of the Statodellarte for purposes of personal or partisan profit or otherwise in conflict with the Fundamentals of the Constitution. They assume in their own name the responsibility for every action carried out in relation to their role. They may not present themselves on behalf of Cittadellarte or of the Presidency of the Camera except by specific delegation.

V. Operating Outside Profit

In coherence with the nature of the Statodellarte, which operates outside any logic of profit, the Ambassador allocates any proceeds deriving from initiatives promoted in the name of the Statodellarte

exclusively to the social and cultural nourishment of communities and to the development of the activities of the Statodellarte itself.

VI. Respect for Dignity and Inclusion

The Ambassador recognises that every human being is endowed with reason and conscience. They promote environments of dialogue founded on mutual respect, on listening and on the valuing of differences. They counter every form of discrimination and work to remove the obstacles that impede the equal enjoyment of rights and the exercise of responsibilities within the Statodellarte, pursuant to Article 12 of the Constitution.

VII. Cooperation among Ambasciate

The Ambassador works to collaborate with the other Ambasciate, in particular with those operating in the same territory or in neighbouring territories, in the spirit of Article 44 of the Constitution. The plurality of Ambasciate in the same place is an occasion for cooperation and not for competition.

VIII. Compliance with the Rules

The Ambassador operates in compliance with the rules of the legal order of the country in which they carry out their activities and with those of international law, pursuant to Article 6 of the Constitution, as well as with the Constitution of the Statodellarte, the regulations issued by the Camera and the guidelines defined by the Collegio delle Ambasciate.

Acceptance

The acceptance of this Charter is a necessary condition for the conferral of the title of Ambassador of the Statodellarte, pursuant to Article 41 of the Constitution. By signing it, the Ambassador declares that they know and accept the principles and rules of the Constitution, that they recognise themselves in the principles expressed in this Charter and that they commit to practising them in the exercise of their mandate.

Validity

This Charter, elaborated by Cittadellarte and delivered to the Statodellarte pursuant to the transitional provisions of the Constitution, enters into force with the inaugural session of the Camera. It may subsequently be amended by the Camera by the procedure referred to in Article 56 of the Constitution, on the proposal of the Presidency. The amendments may in no case modify or alter the provisions of the Constitution.
